AMENDMENTS
to the Resolutions of the Cabinet of Ministers of Ukraine
dated May 10, 2024 No. 539 and dated July 23, 2024 No. 847

1. In the Resolution of the Cabinet of Ministers of Ukraine dated May 10, 2024 No. 539:

1) in paragraph 2:

in the second paragraph, the words "one year" shall be replaced by the words and numbers "18 months";

the paragraph after the second paragraph shall be supplemented with a new paragraph of the following content:

"the provision on the market of chemical products, the labeling and/or packaging of which does not meet the requirements of Sections 3 and/or 4 of the Technical Regulation and which was put into circulation before January 1, 2027, cannot be prohibited or restricted until July 1, 2028 for reasons of non-compliance with these requirements;"

In this regard, paragraphs three and four shall be considered paragraphs four and five, respectively;

in the fourth paragraph, the words and numbers "November 1, 2026" shall be replaced with the words and numbers "November 15, 2027";

in the fifth paragraph, the words and numbers "May 1, 2026, in the case when mixtures are provided on the market for the first time after the specified date, - until" shall be deleted;

2) in paragraph 4, the words "protection of the environment and natural resources" shall be replaced by the words "economy, environment and agriculture";

3) in the text of the Technical Regulation on the Classification of Hazards, Labeling and Packaging of Chemical Products, approved by the said Resolution, and annexes thereto, the word "Ministry of Environment" shall be replaced by the word "Ministry of Economy".

2. In the Resolution of the Cabinet of Ministers of Ukraine dated July 23, 2024 No. 847:

1) in paragraph 2:

in the second paragraph of subparagraph 1, the word "year" shall be replaced with the words and numbers "18 months";

in subparagraph 2:

in the second paragraph, replace the numbers "2026" with the numbers "2029";
in the third paragraph, replace the numbers "2028" with the numbers "2031";
in the fourth paragraph, the numbers "2030" shall be replaced by the numbers "2033";

in the first paragraph of subparagraph 3, the words and numbers "the effect of subparagraph 2 of this paragraph does not apply to an existing chemical substance, which" shall be replaced by words and numbers "paragraphs 17, 18, 20, 21, 67 and 72 of the Technical Regulation shall not apply until October 1, 2028, if the existing chemical substance";

2) in paragraph 3, the words "protection of the environment and natural resources" shall be replaced with the words "economy, environment and agriculture".

3) in the Technical Regulation on the Safety of Chemical Products, approved by the said resolution:

in paragraph 66, after the word "imported", add the words "as separate substances", and replace the words "for production in the composition" with the words "for the purpose of production";

in paragraph 142, the words "one year" shall be replaced by the words "two years";

in the text of the Technical Regulation and its annexes, the word "Ministry of Environment" shall be replaced by the word "Ministry of Economy".
